## SUMMARY

**Jan Wouters** (°14 July 1964) is Full Professor of International Law and International Organizations, Jean Monnet Chair *ad personam* “European Union and Global Governance”, and founding Director of the Institute for International Law (1999) and of the Leuven Centre for Global Governance Studies (2007) at KU Leuven. He is also Administrator of the America Europe Fund. Jan Wouters is a Visiting Professor at the College of Europe (Bruges) and Université Panthéon-Assas (Paris2), where he teaches EU external relations law, and Adjunct Professor at Columbia University (New York), where he teaches on the EU and human rights. Currently *Of Counsel* at Omega Law, he has more than 25 years experience working as an attorney. He is a Member of the Royal Academy of Belgium for Sciences and Arts since 2008.

Jan Wouters studied law and philosophy at the University of Antwerp, obtained a Master of Laws (LL.M.) degree at Yale Law School (1990), was Visiting Researcher at Harvard Law School (1990-91) and obtained his PhD in Law at KU Leuven in 1996. He combines 36 years of academic scholarship and practical experience in most areas of EU law and international law (including general international law, international criminal law, economic law, humanitarian law, human rights law, investment law, law of international organizations, in particular the United Nations (UN), the UN system and the World Trade Organization (WTO), and space law), as well as in corporate, banking and financial law and global governance. He brings a strong insight in the multifaceted interactions between legal norms and governance processes at international, European and national levels. In EU law he has written an award-winning commentary on the Maastricht Treaty (with W. Devroe) and a doctoral thesis on the freedom of establishment of business enterprises. He has extensive practical experience by working as a *référéndaire* at the European Court of Justice and as an attorney since 1997. His unique expertise in both EU and international law was recognized by his indication as a Member of the Arbitration Panel under the UK-EU Withdrawal Agreement in December 2020, as a selected candidate for appointment for the position of Arbitrator and TSD Expert in June 2022, and as Special Council for Belgium in the case *Allegations of Genocide under the Convention on the Prevention and Punishment of the Crime of Genocide (Ukraine vs. Russian Federation)* before the International Court of Justice.

Before being appointed at KU Leuven in 1998, Jan Wouters was Professor at the Universities of Antwerp and Maastricht. He has been a Visiting Professor at world-class universities, such as the Universities of Bologna, Cambridge, Kyushu, Ottawa, the Hebrew University of Jerusalem, LUISS (Rome), the Pontificia Universidad Católica de Chile, Sciences Po (Paris) and the University of Turin. He is Editor of the *International Encyclopedia of Intergovernmental Organizations*, Deputy Director of the *Revue Belge de Droit International*, Editor-in-Chief of the International Law Book Series with Intersentia Publishers and of the Leuven Global Governance Book Series with Edward Elgar Publishing, and editorial board member in eleven international journals. He has published widely on international and EU law, international organizations, global governance, and corporate and financial law (see list of publications *infra*). His most recent books include *China, the EU and the Developing World* (2015), *Global Governance of Labour Rights* (2015), *Global Governance Through Trade* (2015), *The Contribution of International and Supranational Courts to the Rule of Law* (2015), *Global Governance and Democracy* (2015), *Armed Conflicts and the Law* (2016), *Judicial Decisions on the Law of International Organizations* (2016), *Research Handbook on EU Energy Law and Policy* (2017), *Commercial Uses of Space and Space Tourism* (2017), *The Commons and a New Global Governance* (2018), *EU Human Rights and Democratization Policies* (2018), *International Law: a*

Next to his decades-long experience as a lecturer and practitioner, Jan Wouters has extensive experience in managing complex research institutes and projects. At KU Leuven he is founding Director of the Institute for International Law (1999) and of the Leuven Centre for Global Governance Studies (2007). The latter comprises more than 60 junior and senior researchers, and has been recognized as a KU Leuven Centre of Excellence in 2010 and in 2018, and as a Jean Monnet Centre of Excellence in 2016 and in 2020. Jan Wouters has been (co-) promotor of more than 80 research projects for which competitive funding was obtained. He recently coordinated two large European research projects, FRAME ("Fostering Human Rights Among European External and Internal Policies", 2013-17) and RECONNECT ("Reconnecting Europe with its Citizens through Democracy and Rule of Law", 2018-22) and coordinates a six-year multidisciplinary research programme CONNECTIVITY ("Connectivity, Contestation and Cooperation in Global Governance"), funded by KU Leuven.

Apart from his participation in international scientific networks, Jan Wouters advises from time to time various international organizations and governments, trains international officials, and is often asked to comment international and European developments in the media.

Professor Wouters has more than 35 years of practical experience, including expertise from the international judiciary (European Court of Justice, where he was *référéndaire*) and a long-standing practice as attorney (from 1997 to 2023 as *Of Counsel* at de Bandt van Hecke, nowadays Linklaters, Brussels; since September 2023 as *Of Counsel* at Omega Law, Antwerp), advising governments and private clients on issues of international law (e.g. questions of jurisdiction and immunities, human rights, international sanctions, WTO law, various multilateral treaties), EU law (e.g. cross-border provision of services, freedom of establishment, free movement of capital, competition law, state aid, institutional issues) and corporate, banking and financial law (including cross-border mergers, seat transfers and split-offs, cross-border offering of securities and financial services, regulation of banks, investment funds, investment firms, insurance companies, portfolio management and investment advice).

Professor Wouters also has broad experience as a consultant to international organizations at global (e.g. World Bank, UNIDO, Interpol) and regional (e.g. EU, ESA, OECD, Benelux) levels. In recognition of his expertise in international trade law, he has been expert at the Indicative List for Panels of the World Trade Organization since 2008. In recognition of his unique expertise in both EU and international law he was indicated as a Member of the Arbitration Panel under the UK-EU Withdrawal Agreement in December 2020 and was added to the EU list for appointment for the position of Arbitrator and TSD Expert in June 2022.

As President of the Flemish Foreign Affairs Council from 2008 to 2014, Professor Wouters has been advising authorities on more than 150 international treaties (*inter alia* on commodities; cultural diversity; cultural heritage; economic cooperation; environmental protection; EU treaties and external agreements; headquarters agreements of international organizations; humanitarian law; human rights law; labour standards).

Last but not least, Professor Wouters has developed close relations with EU institutions (European Parliament, Commission, Council, EEAS, Committee of the Regions, Economic and Social Committee) and with the UN system, *inter alia* during the 13 years he was President of the United Nations Association Flanders-Belgium.
